Seaway Ties Record for Longest Navigation Season

In 2016, the St. Lawrence Seaway opened for the season on March 21, and closed on December 31. The 286-day long navigation season tied the record first established in 2008 and matched again in 2013. The St. Lawrence Seaway Management Corporation recorded a total of 35 million tonnes of cargo through the locks in 2016; this was down more than 3 percent from 2015. The Seaway system recorded 3773 vessel transits during 2016, down just slightly from 3781 in 2015. Cargos showing increases in 2016 were grain, liquid bulk and general cargo.

As owner of the family business Chris Engel's Greenhouse in southwest Detroit, she prepared countless flower arrangements for Great Lakes vessels and delivered them via the *J. W. Westcott II* mailboat. She was preceded in death by her husband **Richard**, and survived by children **Christopher, Richard,** and **Deborah Kapanowski**, six grandchildren, and three great-grandchildren. Services were held on December 28 at St. Paul's Protestant Church, Harsens Island, MI. Clarence G. "Gil" Porter (#10027), member of Twin Ports Lodge #12, passed away on December 17, 2016, at the age of 93. His career included the US Coast Guard where he was master of the Cutter *Woodrush* and commander of Port of San Francisco. After 24 years of Coast Guard service, he returned to Duluth to begin his second career as a Great Lakes pilot. That winter, he and his friend **Jack Saunders** founded the Lake Carriers' Association's Navigation School. When he retired as a pilot in 1977, **Gil** launched his third career, starting Duluth Magnetic Compass Service which he operated until 2012. He was an active member of many organizations within the Duluth-Superior maritime community. **Gil** was preceded in death by his wife **Helen** and a son **Gilbert "Skip."** He is survived by children **Ken, Cindie Fadden,** and **Lani Paszak**, ten grandchildren, and six great-grandchildren. A celebration of life will be held at a later date.

MMC Credential Processing Delays

On December 23, 2016, the US Coast Guard National Maritime Center issued a bulletin updating credential processing delays, reprinted in part here:

The National Maritime Center (NMC) continues to experience a greater-than-average volume of applications for Merchant Mariner Credentials (MMC). This bulletin outlines actions to be taken for US mariners holding national and STCW endorsements.

National Endorsements: *The USCG is exercising its authority . . . and is granting an extension of national endorsements for any mariner whose MMC expires on or after December 1, 2016. This extension . . . will be valid until September 30, 2017. . . . All mariners sailing exclusively under the authority of their national endorsement on inland or coastwise voyages are advised to carry a copy of this letter [found at https://www.uscg.mil/nmc/announcements/pdfs/2016_national_extension_authorization_letter.pdf] with*

their expired credentials and produce it upon request of USCG personnel or other officials. Expiration dates of new MMCs will be 5 years from the date of expiration of the previous MMC, in accordance with current policy. The extension of validity of expired credentials provides the opportunity for a mariner to work under the authority of that credential during this period, so there is no loss of MMC validity associated with this decision.

STCW Endorsements: The NMC is focusing on evaluating applications with STCW endorsements. In accordance with Regulation I/2 of STCW, we are unable to extend the validity of these endorsements. As a result applications containing MMCs with STCW endorsements will be processed as quickly as possible. . .

Mariner Medical Certificates: Mariners must continue to maintain a valid mariner medical certificate.

Nothing stated in this bulletin is intended to relieve mariners from their responsibility to submit timely applications. . . .

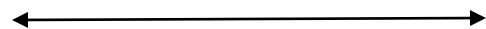


Industry Newsbriefs –

- At its January 26, 2017, meeting, the St. Louis County (MN) Board appointed two new commissioners to the Duluth Seaway Port Authority Board – **Patrick Boyle** and **Pete Stauber**. **Ray Klosowski**, was reappointed by the Duluth City Council in October 2016 to a third, six-year term on the Duluth Seaway Port Authority Board.
- On January 25, 2017, the St. Lawrence Seaway issued a customer advisory, announcing a toll rate increase of 2.0 percent for the 2017 navigation season. The new tariff is available on the Seaway website at http://www.greatlakes-seaway.com/seaway_handbook/seaway-handbook-en/web_schedule_tolls.pdf.
- The US Coast Guard Towing Safety Advisory Committee (TSAC) met via teleconference on January 18, 2017, covering topics such as implementation of Subchapter M, and progress reports from other subcommittees. On January 24, the USCG announced that it is seeking applications for membership on the TSAC. Completed applications must reach the Coast Guard by March 9. - Reminder – The 2017 Light List is now available on the US Coast Guard’s Navigation Center website at <http://www.navcen.uscg.gov/?pageName=lightlists>.
- On January 20, 2017, the US Coast Guard announced a Notice of Proposed Rulemaking – Marine Casualty Reporting Property Damage Thresholds. Initial regulations setting dollar threshold amounts for reporting a marine casualty,

and for reporting a “serious marine incident,” were instituted in the 1980s and have not been updated. Because monetary thresholds have not kept pace with inflation, relatively minor casualties must be reported. Additionally, the regs require mandatory drug and alcohol testing following an SMI; consequently, testing is being conducted for casualties less significant than those intended in the original regulations. Updating this regulation will reduce the burden on vessel owners/operators and will also reduce the amount of USCG resources expended in investigations. Comments on this proposed rulemaking must be submitted by March 24, 2017. - On January 19, 2017, the US Coast Guard Navigation Center announced that “Best Practices for Improving the Operation and Development of GPS Equipment Used by Critical Infrastructure,” is available for download at <http://www.navcen.uscg.gov/pdf/gps/Best%20Practices%20for%20Improving%20the%20Operation%20and%20Development%20of%20GPS%20Equipment.pdf>. The document recommends installation and operation strategies to improve the resilience of equipment receiving.
- On January 18, 2017, the US Coast Guard National Vessel Movement Center (NVMC) posted a notice stating that eNOAD submitters should immediately discontinue use of rich-text (RTF) and HTML formats for eNOAD submissions via email. All eNOAD submissions sent to the NVMC parser (enoad@nvmc.uscg.gov) must arrive in plain-text email format.
