The lodge is pleased to announce that we will have a very special guest in attendance at our March 24, 2003 lodge meeting. Traveling in from Toronto will be Capt. Gary Kassbaum, Senior Regional Investigator for the Transportation Safety Board of Canada. He will explain how the TSB operates, how it responds to maritime casualties and accidents, and what it does to notify the marine community of potential hazards and of corrective measures to be taken by marine officers and personnel. Capt. Kassbaum will discuss the *Windoc*/Bridge 11 incident in the Welland Canal. Included in this portion of the presentation will be actual video footage of the lift bridge coming down onto the *Windoc* as the vessel was passing under the bridge, a dramatic video to say the least. In addition to the *Windoc* incident, Capt. Kassbaum will discuss another bridge related incident, this one involving the *Catherine Desgagnes* doing significant damage to marinas while trying to pass through a bridge on the Black River of Lorain Harbor. Capt. Kassbaum was the Senior Investigator following these incidents and he feels that there is much to learn about bridge/vessel safety as a result of the TSB investigations. This program will be of great interest, especially to mariners who pass through bridge openings on a regular basis.

An updated lodge program/meeting schedule is included in this mailing to reflect the addition of Capt. Kassbaum's program to the lodge's schedule.

Congratulations are extended to lodge members Alan Flood and Gus Markakis, who each received a Capt. Lewis Ludington Award during the recent Blessing of the Fleet at Mariners' Church. Also receiving a Ludington Award was Capt. Hicks McBeth, senior member of Port Huron Lodge No. 2.
