Serving in the honor guard during the bell ringing portion of the service were Ron Ingram, Ted Cogswell, Art Herrala,, John Sarns, Ken Suddick, Jack Frost, Rick Scott and Mel Riecher of Lodge No. 7, and Roger Hewlett, Jerry Knox, Bill Barnhardt and Brian Eickel of Port Huron Lodge No. 2. Rector Richard Ingalls, Jr. and Sexton Kathy McGraw were in attendance serving in their official capacities at Mariners' Church. Several **members participated in additional memorial events** this month. Fr. Ingalls officiated at a memorial service at the Great Lakes Shipwreck Museum on Whitefish Point in the Upper Peninsula on Wednesday, November 10. The service marked the 35<sup>th</sup> anniversary of the sinking of the *Edmund Fitzgerald*. The Lost Mariners Remembrance at Dossin Great Lakes Museum also took place on November 10. Malcolm McAdam was the coordinator and master of ceremonies, Co-Chaplain Russell Kohler was a participating clergyman, Jack Callahan served as a wreath bearer and Kathy McGraw served as necrologist. Several **members were mentioned in various media publications** in recent months. The *Detroit Free Press* of August 29, 2010 had a feature story about the "Ships Spectacular" weekend at Dossin Great Lakes Museum. The event was part of the museum's year-long 50<sup>th</sup> anniversary celebration. Sam Buchanan piloted the *J.W. Westcott II* mailboat to the museum for the event and was interviewed for the story. Larry Stephenson and James Ramsey recently enjoyed a trip on the *M/V Stewart J. Cort*, as guests of incoming Grand Lodge President Tom McMullen. Larry and Jim wrote about their experience aboard the *Cort* in the Late Spring 2010 issue of *The Grosse Pointer*, a publication of the Grosse Pointe Yacht Club. The article "Superior Adventure Crossing Gitchigumi, Part

II" describes life aboard ship for Capt. McMullen and his crew. Jim Hogan and Jason Elliott were interviewed for the article "Long history of freighter navigation on the Detroit River" that appeared in the October 31, 2010 edition of the *Macomb Daily*. Rev. Richard Ingalls, Jr. was interviewed for an article about Mariners' Church "Anchored in Rich History" that appeared in The Insider section of the November, 2010 edition of *Hour Detroit* magazine. Fr. Russell Kohler appeared twice in issues of the *Michigan Catholic*. The October 8, 2010 issue profiled his work with cancer patients at the Pope John Hospitality House in midtown Detroit. The November 19, 2010 issue reported on the 175<sup>th</sup> anniversary of Most Holy Trinity Church in Detroit's Corktown neighborhood where Fr. Kohler has served as pastor since 1991.
